All guests MUST complete a separate registration form and waiver before joining an activity.

### CSC Waiver (mandatory)

By signing I agree that :

I am 18 years or older, have read this document throughly and have been given the opportunity/advised to seek legal counsel before signing;  
I acknowledge that the activities organized by members, officers, employees, agents and contractors of the Calgary Ski Club (hereby known as "CSC") contain inherent risks and involve natural and man-made hazards;  
I understand and accept the nature and extent of the risks of these activities;  
I am executing this release and waiver of liability freely and voluntarily without compulsion on the part of the CSC;  
I understand that CSC coordinators are not professional guides/leaders or licensed first aid attendants, and may/may not have any outdoor leadership or first aid experience;  
I understand that they and CSC members are not responsible for my/children's safety in activities which I participate in;  
I take full and sole responsibility as a result of participating in these activities in the event of any serious injury/death of myself and/or my children;  
I acknowledge that CSC is not responsible for any loss and/or damage sustained by me including loss/damage caused by injury to my and my person/property and by death howsoever caused, notwithstanding the same may have been caused by/contributed to by the negligence of the CSC;  
This Membership Agreement, Waiver of all Possible Claims and Assumption of Risk and Release of Liability applies to all activities which I/my children participate whether in the near or distant future;  
This Waiver must be signed annually in conjunction with my initial application and does not need to be signed or brought to my attention before each activity during this membership year to be effective;  
CSC will not allow myself, either as a guest or member, and/or the children that I bring to participate in any of their activities unless this Agreement, Waiver of all Possible Claims and Assumption of Risk and Release of Liability is signed by myself and/or my parent/guardian;  
This Membership Agreement, Waiver of all Possible Claims and Assumption of Risk and Release of Liability shall be governed by the Laws of the Province of Alberta;

CSC collects and uses my personal information for program development and marketing purposes, for contact purposes, to meet legal requirements, and may use my photo from club activities for promotional purposes including brochures and website;

I am aware of the nature and effect of this release and waiver agreement and on my behalf and that of my heirs, executors, administrators and assigns, I hereby release, waive and discharge CSC from all liability whatsoever to myself and such parties for all loss, claims, damages whatsoever on account of injury to my person and/or property or my death whether caused by the CSC or otherwise and I agree not to sue the CSC for such claims.
