

**Family CSC (Member) Waiver**

By signing this mandatory waiver, I state and agree on my own behalf ("I" or "Me"), and on behalf of my family (collectively "We", "Our" or "Us") that:

1. I am 18 years of age, or older, have read this document thoroughly, and have been given the opportunity to seek legal counsel and advice before signing.
2. We acknowledge and accept that the activities (the "CSC Activities") organized by members, event coordinators, officers, employees, agents and contractors of the Calgary Ski Club (the "CSC") involve inherent risks and involve natural and man-made hazards.
3. We understand and freely accept the nature and extent of the risks of the CSC Activities.
4. I am executing this release and waiver of liability freely and voluntarily without any compulsion on the part of the CSC.
5. We understand and accept that the CSC members, event coordinators, officers, directors, employees, agents, volunteers and contractors are not professional guides, leaders or licensed first aid attendants and that they may not have guide, leadership or first aid experience.
6. We understand that We, and not the CSC members, event coordinators, officers, directors, employees, agents, volunteers and contractors, are responsible for Our safety in the activities in which We participate.
7. In participating in any CSC Activity We take full and sole responsibility for Our wellbeing and take full and sole responsibility for any injury We suffer or Our, or any one of Our deaths as the case may be.
8. The CSC is not responsible for any loss and/or damage sustained by Us or any of Our property including any loss and/or damage caused by injury or death, howsoever caused, ***notwithstanding the same may have been caused or contributed to by any act, omission or negligence of the CSC.***
9. This CSC waiver applies to all activities in which We participate while We are registered members of the CSC. We acknowledge that the CSC will not require me to sign a waiver form before each activity in which We take part and confirm and accept that this waiver applies to all CSC Activities in which We partake.
10. This waiver must be signed on an annual basis in conjunction with my annual CSC membership application and We accept and agree that We cannot participate in any CSC Activity unless this waiver has been signed by Me.
11. This waiver, and all other documentation and contracts that bind Us in conjunction with Our membership with the CSC, shall be governed by the Laws of the Province of Alberta.
12. The CSC may collect and use Our personal information for program development, marketing and contact purposes, to meet all legal requirements and may use any photograph of Us during Our participation in a CSC Activity for promotional purposes including brochure and website marketing. We consent to the use of Our personal information for the foregoing reasons, only. All information will not be otherwise used or distributed unless ordered by a Court of competent jurisdiction or as otherwise directed by law.
13. We are aware of the nature and effect of this waiver and fully understand its implications and its limitations on my rights of recovery against the CSC for any losses and damages We sustain during Our participation in CSC events and on Our behalf and that of Our heirs, executors, administrators and assigns, We hereby release and forever discharge the CSC from all liability whatsoever for all loss, claims, or damages whatsoever on account of injury to Us and/or Our property or death, whether caused by an act or omission of the CSC or otherwise and We agree not to commence legal proceedings against the CSC for such claims.
